-READ BEFORE SIGNING-

In consideration of being allowed to participate, in any way, in Narragansett Bow Hunters (NBH) events and activities, the undersigned acknowledges that:

- 2) I acknowledge and agree that the use of archery equipment and other weapons by myself or others on club premises or otherwise are inherently dangerous and high risk activities whether such archery equipment or weapons are discharged by myself or others; and,
- 3) I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
- 4) I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
- 5) I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY directors, officials, agents, employees, volunteers, members, guest, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of real property and personal property used to conduct the activities, WITH RESPECT TO MY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to personal property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.
